The problem with paint

Paint contains chemical components (binders, solvents, pigments, driers, conservation agents and thinners), some of which are harmful to people and the environment. Among the culprits are VOCs, or volatile organic compounds. These are hydrocarbons that evaporate easily. Once in the atmosphere, they react with sunlight and nitrogen dioxide, which increases the concentration of ozone. For this reason, VOCs are connected to a number of environmental problems, including air pollution and acidification. It is also known that they can have harmful effects on the health of vulnerable groups of people, for example by causing respiratory problems.

People who come into direct contact with paint are at the greatest risk. Brief exposure without adequate ventilation can lead to nausea, headaches, dizziness, etc, but the symptoms disappear shortly afterwards. However, with regular and longer exposure, this can result in permanent irreparable damage to the nervous system and brain functions.

Striving for the best solution for our customers

Under European Directive 2004/42/EC and the resulting national legislation, the maximum proportion of VOCs in grams per litre of ready-to-use paints and varnishes is strictly limited. Aside from a few well-defined exceptions for certain sectors and applications, it has not been permitted to use or sell paints that exceed these established maximum values since the 1st of January 2010.

This involves paints and varnishes for the interiors and exteriors of buildings that are applied by professional painters as well as by private individuals.

Although paint manufacturers have done their best to modify their products, and the levels of VOCs in paints and varnishes have been reduced dramatically, their impact on people and the environment remains considerable. They are only safe for people and the environment with the correct painting technique and high quality paint that contains little or no solvents.

The Paracem Deco Nature range of paints is the best choice for anyone who is concerned with their own well-being and that of others. These interior wall and ceiling paints are registered with the prestigious **European Ecolabel mark**. The Ecolabel is awarded to products and services that have a lower environmental impact, for example with reduced waste and lower emissions for the air, water and soil.

Furthermore, Paracem Deco Nature paints are just as good as conventional interior wall and ceiling paints in terms of ease of use and performance, so the same level of productivity is maintained.

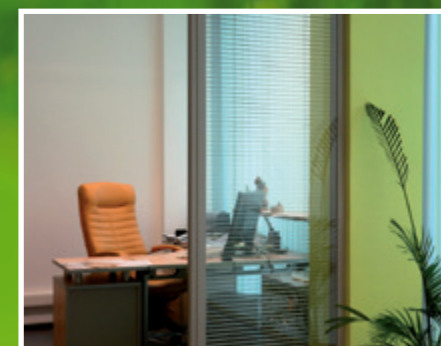
Europe is increasingly requiring countries to use Ecolabel certified paints for applications in public spaces such as hospitals, municipal public buildings, rest homes, day-care centres, etc.

Paint registered with the Ecolabel must meet a number of strict requirements:

- It must be of top quality.
- The paints must meet certain technical specifications such as coverage, wet scrub resistance.
- They must be entirely free of heavy metals and other harmful substances.
- There are limit values for air pollution, reduced sulphur emissions and the amount of waste generated in the production of these paints.
