# PRACTICAL CONSUMPTION

Practical coverage depends on many factors such as porosity and roughness of the substrate and material losses during application.

### **SURFACE PREPARATION**

- New work: the substrate needs to be clean, dry and free of fats and oils. The substrate has to be primed with Fassiprim Aqua.
- Existing work: clean, degrease and sand. Remove loose, flaking or cracked paint layers. Treat hare snots as new work.
- Block wood knots and sap streaks with Zinsser primer B-I-N.
- For stain, graffiti, tannin and other substances bleed blocking, and/or very fast recoating on all substrates, use Zinsser primers Bulls Eye 123 or 123 Plus.

# **DIRECTIONS FOR USE**

To ensure homogeneity, coating materials should be thoroughly stirred prior to use.

# APPLICATION CONDITIONS

- 10-30 degrees C. Relative humidity < 80%.
- Temperature of the substrate at least 3 degrees C above the dew point.

# **APPLICATION & THINNING: BRUSH**

Dilute, if necessary, up to maximum 5% volumewith water

# **APPLICATION & THINNING: ROLLER**

Dilute, if necessary, up to maximum 5% volume with water

#### APPLICATION & THINNING: AIRLESS SPRAY

- Nozzle: 0.011 0.013 inch / Pressure: 120 bars.
- Thinning 3% volume water.

# **APPLICATION & THINNING: AIR-ATOMISED SPRAY**

- Nozzle 1,5 2,0 mm / Pressure: 2 3 bars.
- Thinning 10 15% volume water.

#### **CLEANING OF EQUIPMENT / SPILLS**

Warm water

If conventional spraying is used, the gloss might be somewhat lower.
