## SURFACE PREPARATION

New wood: rub down and make it dust free. Tropical wood is degreased with white spirit: Afzelia with ammonia water.

Old stripped paint: rub down to the bare not impregnated wood fibre and make dust free. Maintenance on Fassitek Thixo: clean substrate with white spirit and apply 2 or 3 thin coats.

# **DIRECTIONS FOR USE**

To ensure homogeneity, coating materials should be thoroughly stirred prior to use.

# APPLICATION CONDITIONS

Apply in a dry and well-ventilated area. > 5°C, < 80% R.H.
