#### Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Get medical attention if adverse health effects persist or are severe. #### 8.2 Exposure controls

Appropriate engineering controls

 Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

#### **Individual protection measures**

**Hygiene measures**
